

# Application for Registration for Mineral Oil Tax on Vehicle Gas



This registration form should be completed by applicants intending to supply natural gas or biogas for use as fuel in a motor vehicle. This form should not be used by suppliers of mineral oils such as petrol, diesel, and LPG.

## Notes for completing this form

1. The MOT VG Registration form must be signed by the supplier concerned or by the competent person in the State appointed by a supplier not established in the State to account for and pay Mineral Oil Tax on Vehicle Gas in the State.
2. Where the supplier or competent person is a body corporate, the MOT VG Registration form must be signed by a director, the company secretary or by a person who is authorised in writing under the company seal. That person must state their position within the business, e.g. Company Secretary, Director, partner, etc. as appropriate.
