Week commencing Monday Sept 17<sup>th</sup> to Monday November 19<sup>th</sup>

### Participation

- 25 payroll providers nominated 234 employers, with ~500,000 employees
- 39 of 234 employers have successfully submitted their List of Employees

### Customer On-Boarding

- 40 participating customers have requested certificates via MyEnquiries
- Revenue will commence issuing certificates via MyEnquiries this week
- Customers may use these certs to create PREM-Only sub-certs as per Live



# **TLS – Supported versions**

Query raised regarding the TLS setting in PIT vs Live

- TLS 1.0 is end of live
  - Currently IE 8, 9 and 10 have support for TLS 1.2 disabled by default which is why we've continued to allow TLS 1.0 in live for now
- However TLS 1.2 should be used for PMOD services
- Revenue's supported protocols are under constant review to balance security against ongoing support for older browsers;
