CAB update

CAB update

- CR002 - APPROVED
 - Addition of additional superannuation contribution data item to payroll submission.
 - This change will involve a new conditional field, EmployeeASC, being added to both the JSON and XML schemas for the Payroll Submission service. It will also require an update to the 'Payroll Submission Data items' document.
 - Release this change is delivered to PIT as part of the June 19th release.

CAB update

- CR003 – APPROVED implementation date TBC
 - Our REST Digital signing implementation differs from the international standard that our documentation states we are following (IETF HTTP Signatures Draft) so we are proposing that we bring it in line with that standard. For payroll software using our REST services, this will involve a change to how messages are digitally signed.

CAB update

- CR003 – APPROVED implementation date TBC
 - For payroll software using our REST services, this will involve a change to how messages are digitally signed.
 - Currently our digital signature verification expects the 'request-target' not to include the full public context path or query parameters:
 - For Example:
 - The RPN services expects the 'request-target' field to include post `/v1/rest/rpn/{ employerRegistrationNumber }/{taxYear}`
 - However if our implementation was in line with the appropriate standards, the RPN service should expect the 'request-target' field to include the full public context path and the query parameters (if applicable)
 - For Example:
 - `post /paye-employers/v1/rest/rpn/{ employerRegistrationNumber }/{taxYear}?dateLastUpdated={date}`

Providing PPSN for first time

- Payroll submissions made for an employee with no PPSN. Employer Reference included
- First time reporting with the PPSN
 - Include flag on submission that it is first time reporting with PPSN
 - Include employer reference number on RPN request as an optional item where submissions have been made in the past with no PPSN
 - Other options?

Definition of pay date update

Definition of pay date update

- *Date Employee is being paid (YYYY-MM-DD). In the case of an individual paid by cash, it is the date the cash is given to the employee. Where payment is made by bank transfer, it is the date on which the funds are scheduled to be made available in the individual's bank account. In the case of a cheque, it will be the date on the cheque. Where payday falls on a **day which is not a bank working day** and an employee is due to be paid by funds transfer on that day, we would regard the payday as that **day which is not a bank working day** where the funds are made available to the employee in his or her bank account on the previous day.*

Definition of pay date update

- Scheduled pay date is 1 February which is a Sunday.
- The payslips and payroll operation should be based on that date.
- However, if the funds are made available in the bank account on the previous Friday, i.e. 30th January, we would still regard the pay date as 1 February.

Compression

Compression

- Compression of inbound messages supported for REST services (GZIP compression)
- Compression of outbound messages will be available on both REST and SOAP (GZIP compression)
 - If requested by client in the http header, message responses will be compressed
- Webservice integration guides will be updated to include details on inbound/outbound compression
