

Income Tax 2023: Insights on PAYE Taxpayers

Average Contribution of Pension Contributors

Pensions contributions by employees and employers (through employments) totalled €4.0 billion and €3.8 billion respectively in 2023. 1 in 3 employees made a pension contribution in 2023. As shown in the graph, pension contributions typically increase with income.

The gender breakdown of pension contributors in 2023 was 52 per cent female to 48 per cent male. Although females made up a higher share of contributors, males contributed more by value, €2.2 billion compared to €1.8 billion by females.

Revenue's Survey of PAYE Customers 2023



72 per cent of respondents were either satisfied or very satisfied with Revenue and the services provided.

The top three reasons customers engaged with Revenue were to review their Preliminary End of Year Statement (PEOYS), to enquire about tax credits and tax reliefs, and to view their employment detail summary.



The survey report also examined key aspects of PAYE taxpayers' tax literacy. Most PAYE customers (85 per cent) actively monitor the income and transfers they receive. 81 per cent knew how to inform Revenue of other sources of income they received. However, 22 per cent indicated they struggle to complete tax credit or relief claim forms.

Customs Duties in 2023

€586m in Customs Duties was collected in 2023, a fall of 5 per cent. The decrease was primarily due to declines in the import of clothing and fertiliser.

There has been a steep increase in customs duties since 2021, when Great Britain became a Third Country.



China is the top country of origin for customs duties, while the US is the top country of origin for imports by value.

Excise Registers

The Excise Acts, and their associated regulations, require that Revenue publish a series of registers for Excise customers. These registers are updated monthly:

- Current Valid Licensed Auto Fuel Traders
 - Licensed Marked Fuel Traders
 - Register of Licensed Bookmakers
- Licensed Remote Bookmaking Operations
 - Register of Bookmaking Offices
 - Register of Renewed Liquor Licences
