## ***Audience***

This document is for any accountable person who is registered for Professional Services Withholding Tax (PSWT) and wishes to upload a CSV file with the details of the payment notifications for each of the specified persons they have withheld tax from.

## ***Document Context***

This document provides a description for each column on the Professional Services Withholding Tax Payment Notification CSV Template. This document corresponds with version 21.3.0 of the Payment Notification CSV Template.

Note: This method of notifying Revenue of Payment Notifications (i.e. via CSV file upload) can only be used to notify Revenue of new Payment Notifications. All Payment Notification line-items that pass the validation rules will be treated as new Payment Notifications. The CSV file upload method cannot be used to amend existing Payment Notifications. Any amendments must be performed via the ePSWT web application, which will be accessible via ROS once the system goes Live.

The maximum number of line-items that can be uploaded to the ePSWT system is 4,000.
