Sample Questions

Using the Rate Bands, Tax Credits, Tax Basis and USC Handout, complete the following questions. Show your workings in the space provided.

Question 1

Azfar works in an insurance company. He is single and earns €25,000 per year. Calculate his gross tax.

	€
$€25,000 \times 20\%$	<u>5,000</u>
Gross Tax	5,000

Question 2

Mia works in an IT company. She is single and earns €50,000 per year. Calculate her gross tax.

	€
$€40,000 \times 20\%$	8,000
$€10,000 \times 40\%$	<u>+ 4,000</u>
Gross Tax	5,000

Question 3

Yihang works as a graphic designer. He is single and earns €660 per week on the first week of the year. Calculate his gross tax.

	€
$€660 \times 20\%$	<u>132.00</u>
Gross Tax	132.00

Question 4

Kevin works in a marketing firm. He is single and earns €800 on the first week of the year. Calculate his gross tax.

	€
$€769.23 \times 20\%$	153.85
$€30.77 \times 40\%$	<u>+ 12.31</u>
Gross Tax	166.15

Question 1

Alex is single and earns €35,000 per year. Calculate her gross tax.

	€
$€35,000 \times 20\%$	<u>7,000.00</u>
Gross Tax	7,000.00

Josh is single and earns €50,000 per year. Calculate his gross tax.

	€
$€40,000 \times 20\%$	8,000.00
$€10,000 \times 40\%$	<u>4,000.00</u>
Gross Tax	12,000.00

Question 3

Andrei is married. His spouse is not currently working. He has a salary of €23,000 per year. Calculate his gross tax.

	€
€23,000 x 20%	<u>4,600.00</u>
Gross Tax	4,600.00

Question 4

Fiadh is single. This week she was paid €300. She is taxed on a week 1 basis. Calculate her gross tax.

	€
€300 x 20%	<u>60.00</u>
Gross Tax	60.00

Question 5

Ushen is single. This week he was paid €750. He is taxed on a week 1 basis. Calculate his gross tax.

	€
€750 x 20%	<u>150.00</u>
Gross Tax	150.00

Question 6

Mark is single. He was paid €2,000 this month. He is taxed on a month 1 basis. Calculate his gross tax.

	€
€2,000 x 20%	<u>400.00</u>
Gross Tax	400.00

Question 7

Sadie is married. Her spouse is not working. This month she was paid €4,000 on a month 1 basis. Calculate her gross tax.

	€
€4,000 x 20%	<u>800.00</u>
Gross Tax	800.00
