Employment Wage Subsidy Scheme (EWSS)

The EWSS is an economy-wide enterprise support. The Scheme provides a flat-rate subsidy to qualifying employers based on the numbers of eligible employees on the employer's payroll. EWSS replaced the Temporary Wage Subsidy Scheme (TWSS) from 1 September 2020 and was expected to continue until 31 March 2021. It was announced in Budget 2021 that the Scheme will be extended to end of 2021. Both Schemes ran in parallel from 1 July 2020 until the TWSS ceased at the end of August 2020.

The TWSS and the EWSS are operated by Revenue through the payroll system to support employers and employees through the COVID-19 pandemic.

Revenue has processed payments of €254m for EWSS claims for September. 32,700 employers are due an EWSS payment in respect of 341,200 employees for this period.

Revenue has processed payments of €22.8m for backdated EWSS claims for July/August in respect of newly or seasonally hired employees who were ineligible for the TWSS. 4,500 employers are due an EWSS payment in respect of 21,700 employees for this period.

38,700 employers have registered with Revenue for EWSS.

Revenue will publish a comprehensive statistical overview of the TWSS once payslips for the relevant period are finalised.


